1. AVAS FOOD is a food delivery company (delivery) with its own delivery employees, which receives orders from customer for a Restaurants, collect and delivery food to customer in Maldives. We use contact information of individuals for delivery purpose.

When you use AVAS FOOD, you trust us with your personal data. We're dedicated to keeping that trust.

2. This notice applies to users (customers) of AVAS FOOD services anywhere in the Maldives.

For example, we may collect the contact information of individuals while registering who users our mobile application for delivery purpose

3. AVAS collects:

Data provided by users to AVAS, such as during account creation

Data provided by users. This includes, User profile: We collect data when users create or update their AVAS accounts. This may include their name, email, phone number, and address. Further, we collect **Current Location Information** as well for the reason explained below.

The users can see the merchants on our app who are within **3KM** radios from **current location** of the user. In addition, we use the user's location info for delivery efficiency such as to show the shortest delivery path for delivery riders.

4. How we use personal data

AVAS collects and uses data to enable reliable and convenient delivery service. We also use the data we collect:

- For customer support
- To enhance the quality of our users
- To send marketing (promotions) and non-marketing communications (changes to our terms & conditions) to users
- In connection with legal proceedings

AVAS does not sell or share user personal data with third parties for their marketing.

5. Cookies and third-party technologies

AVAS use cookies to store and process AVAS data. AVAS don't use cookies to collect personal data of users.

6. Data sharing

We may also share limited data with our employees for delivery purpose

7. For legal reasons or in the event of a dispute

AVAS may share users' personal data if we believe it's required by applicable law, regulation, or governmental, or where the disclosure is otherwise appropriate due to safety or similar concerns. This includes sharing personal data with law enforcement officials, other government authorities

8. Data retention

AVAS retains user profile, and other personal data for as long as a user maintains their account.

AVAS may retain certain user data from unused account if necessary, such as to comply with legal requirements.

9. To provide requested services,

In order to provide our services, we must collect and use certain personal data.

10. To fulfill AVAS's legal obligations

AVAS FOOD is subject to laws and regulations in Maldives that require it to collect and retain data about our users. We collect and use personal data to comply with such laws.

11. Google API (location API)

We use Google API to show the current location of the delivery person to enhance the quality of the service. But we don't pick up the location of the customer for any reasons.

12. Updates to this notice

We may occasionally update this notice. If we make significant changes, we will notify users in advance of the changes through our website, email or SMS. We encourage users to periodically review this notice for the latest information on our privacy practices.
